We work with families, veterinarians, and local service providers to target the root causes of animal suffering and offer humane, life-changing solutions. Napa Humane is the trusted partner for animal welfare in Napa County since 1973. As the most-well established organization in the region, Napa Humane is the first line of response in the prevention of needless animal suffering. We provide the following critical care and prevention services:

- Subsidized spay/neuter surgeries and microchipping for every animal at the Napa County Animal Shelter.
- Below cost spay/neuter services -- provided not just to our direct clients and constituents but to other animal welfare organizations in the area -- all underwritten by our fundraising efforts.
- Wellness Clinics removing barriers and access to care for families in need.
- Behavioral helpline and education programs, helping clients and community members resolve issues before they arise.

Napa Humane operates the <u>only</u> permanent, dedicated low-cost spay/neuter clinic in Napa, Lake, and Solano counties.
